About UCASA:

In 1996, the Directors of Utah's four rape crisis centers joined together, forming a Coalition to "advocate for and facilitate accessible services for rape and sexual assault survivors in the state of Utah, respecting human dignity and promoting the establishment of superior intervention care, to strengthen and encourage issue awareness and sensitivity toward respective unique cultural gender, ethnic, and economic needs."

Today, UCASA continues to provide advocacy, resources, and training for Utah organizations and individuals engaged in sexual violence prevention and response, and empowers survivors and members of underserved, marginalized and oppressed populations to inform and lead the way in transforming community and professional response to those who commit sexual violence and those who are harmed by the consequences. We advocate for public policy measures that will increase resources for sexual violence prevention, support comprehensive and culturally responsive services for survivors, and promote accountability for those who commit sexual offenses.

We offer this Annual Report to highlight a selection of the significant achievements and outcomes of UCASA programs and partnerships in 2014.

UCASA is incredibly grateful to our partners including professionals, community members, and most especially survivors who have joined together in the work of confronting sexual violence in all its forms. UCASA PROGRAMS AND SERVICES

Public Policy

- UCASA works with community members, service providers, state agencies, and legislators to develop and enact policies that protect victims' rights and increase offender accountability.
 - UCASA staff provided consultation, technical assistance and public education on the following policy measures passed during the 2014 session of the Utah State Legislature:
 - HB0157 RAPE KIT PROCESSING AMENDMENTS Provides guidance for law enforcement on communicating with victims of sexual assault about the evidence collected in their case.
 - HB0212 DNA AMENDMENTS Requires collection of DNA sample at the time of booking for any person arrested for any felony offense.
 - HB0286 CHILD SEXUAL ABUSE PREVENTION Allows schools to provide evidence-based, ageappropriate education for students in grades K-12, and requires sexual abuse prevention education for school personnel and parents/guardians of elementary school children.
 - o **Appropriation of \$750,000** to the Department of Public Safety Programs and Operations to expedite the analysis of forensic evidence collected in over 1,000 previously un-submitted sexual assault kits.



Sexual Assault Service Coordination

UCASA assists partner agencies with coordination and delivery of Sexual Assault Counselor Training which includes 40 hours of interactive instruction and skills development on providing trauma-informed and culturally responsive assistance and advocacy for adult and adolescent survivors of all forms of sexual violence, including stalking, online harassment, workplace harassment, dating violence, and intimate partner sexual violence.

 In 2014, UCASA staff coordinated twelve Sexual Assault Counselor Certification trainings in partnership with providers in four urban and three rural communities serving 16 counties and 4 military branches. 239 participants completed the training and received Sexual Assault Counselor Certification.



Sexual Assault Response Team (SART) Coordination

- UCASA's SART Coordinator supports the development and sustainability of local multidisciplinary teams that include police, prosecutors, advocates, medical staff, and social service providers in identifying protocols for delivering consistent, culturally relevant and victim-centered sexual assault response based on the unique needs and resources of their own communities.
 - o In 2014 UCASA's SART Coordinator provided training and technical assistance to SARTs at various stages of development in fourteen Utah communities.



<u>Sexual Assault Nurse Examiner (SANE) Coordination</u>

- UCASA's Sexual Assault Nurse Examiner (SANE) Coordinator facilitates bi-annual training for nurses
 preparing to become SANE certified, on-site skills training for practicing SANEs training on
 collection, documentation, and presentation of forensic evidence in sexual assault investigation
 and prosecution.
- The SANE Coordinator also provides technical assistance and consultation via phone, e-mail, and site visits on patient care, evidence collection, SANE development and sustainability, and HIV prophylaxis and treatment protocols for victims of rape and sexual assault.



Community Outreach and Education

- The UCASA staff develops and delivers educational outreach and professional development presentations to Utah communities that increase understanding and responsiveness to the needs of sexual assault survivors, with a focus on serving communities that have historically been marginalized or underserved.
 - In 2014 UCASA staff gave community presentations on sexual violence prevention and response to over 150 refugee youth and 78 adults from refugee communities through the Human Rights Education Project in collaboration with the Human Rights Commission of the Salt Lake City Mayor's Office on Diversity and Human Rights




Sexual Violence Prevention

- UCASA promotes a public health approach to the primary prevention of rape and sexual assault that works on the individual, community, and societal levels to decrease risk factors and increase protective factors for sexual violence perpetration and victimization.
 - Following the passage of HB286 Sexual Violence Prevention sponsored by Representative Angela Romero with the support of UCASA and statewide partners, the Utah Department of Health, Utah Office of Education and local prevention educators to are developing guidelines for the development and approval of appropriate prevention education materials that shall be presented by school districts to teachers and parents annually effective Fall of 2016, as well as sexual violence prevention education that Districts may choose to provide for students in grades K-6.
- UCASA provides resources, technical assistance, and curriculum to prevention educators, youth serving organizations, parents, and teens working to promote healthy, respectful relationships among youth and their peers.
 - In 2014 UCASA's Prevention Specialist provided training and technical assistance on building community coalitions and identifying effective prevention resources to Salt Lake County Youth Services, State of Utah Department of Education, "La Jefa" Spanish Language radio station, Centro de La Familia, Rape Recovery Center, MAN Utah, New Horizons Crisis Center, New Hope Crisis Center, Safe Harbor, Boys & Girls Club, Centro Hispano.
 - In 2014 UCASA's Prevention Specialist provided 6 educational sessions for a total of 67 college
 and high school students at YWCA Salt Lake City, Salt Lake Boys and Girls Club, University of
 Utah, Genesis Corrections Center and Westminster College covering the subjects of Healthy
 vs. Unhealthy Relationships, Rape Culture, Bystander Intervention and Rape Myths.
